Public Spaces Protection Order 2024

Control of Dogs

This Order is made by South Hams District Council ("The Council") under the Antisocial Behaviour, Crime and Policing Act 2014 Section 59 ("the Act") and remains in force for a period of 3 years from the date of the Order.

1. This Order relates to:

(i) All land which is in the administrative area of the Council and which is open to the air (which includes land that is covered but open to the air on at least one side) and to which the public are entitled or permitted to have access (with or without payment), ("the restricted area"),

And

- (ii) The designated areas described in the Schedule below and defined in each of the plans attached to this Order being public spaces in the Council's administrative area to which the Act applies,
- (iii) Except land that is placed at the disposal of the Forestry Commissioner under section 39(1) of the Forestry Act 1967 and Dartmoor National Park Common lands.
- 2. The Council is satisfied that the 2 conditions below have been met, in that:
 - (i) Activities carried out in the restricted areas as described below, have had a detrimental effect on the quality of life of those in the locality, or it is likely that these activities will be carried on in the public places and that they will have such an effect. The said activities being dog fouling, dog(s) off leads, dogs in exclusion areas.
 - (ii) The effect or the likely effect of the activities described above, is, or is likely to be of a persistent or continuing nature, is, or is likely to be such as to make the activities unreasonable, and justifies the restrictions imposed by the Order.

BY THIS ORDER

3. The effect of this Order is to impose the following prohibitions and/or requirements at all times:

In the restricted area any person who does not comply with the following requirements commits an offence:

Fouling

If, at any time in the restricted area, as indicated in the Schedule below, a person who is in charge of the dog at the time (or if a minor, the person responsible for the dog) fails to carry the means (dog bags or other container) to collect dog waste.

If, at any time in the restricted area, as indicated in Schedule below, a dog defecates and a person who is in charge of the dog at the time (or if a minor, the person responsible for the dog) fails to remove the faeces from the land forthwith and properly dispose of it, that person shall be guilty of an offence unless:

- (i) He/she has reasonable excuse for failing to do so: or
- (ii) The owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his/her failing to do so.

For the purposes of this Order:

- i) A person registered as blind in a register compiled under section 29 of the National Assistance Act 1948 shall not be guilty of an offence if they are alone with the dog and unable to remove the faeces;
- ii) A person with a disability which affects his mobility, manual dexterity, physical coordination or ability to lift, carry or move everyday objects and who relies for assistance on a dog trained by a prescribed charity (and is clearly identified) shall not be guilty of an offence if they are alone with the dog and unable to remove the faeces. A "prescribed charity" is:
- Dogs for the Good (Registered Charity no. 1092960)
- Support Dogs (Registered Charity no. 1088281)
- Canine Partners for Independence (Registered Charity no. 803680)
- iii) Taking the faeces away from the land for proper disposal elsewhere or placing the faeces in a receptacle on the land, either a litter bin or dog waste bin, shall be sufficient removal from the land.
- iv) Being unaware of the defecation (whether by reason of not being in the vicinity or otherwise), or not having a device or other suitable means of removing the faeces shall not be a reasonable excuse for failing to remove the faeces.
- iiv) A person who habitually has a dog in his/her possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.

B. Dogs on Leads

A person in charge of a dog shall be guilty of an offence if, at any time on land within the restricted area detailed in the Schedule below, he/she does not keep the dog on a lead unless

(i) He/she has reasonable excuse for failing to do so: or

(ii) The owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his failing to do so.

(iii) Failing to have a lead in his/her possession at the time shall not be a reasonable excuse for failing to do so.

For the purposes of this article a person who habitually has a dog in his/her possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.

C. Dogs on Leads by direction

A person in charge of a dog shall be guilty of an offence if, at any time within the restricted area specified in the Schedule below, does not comply with a direction given to him/her by an authorised officer of the Authority to put and keep the dog on a lead, unless:

(i) He/she has a reasonable excuse for doing so; or

(ii) The owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his/her failing to do so.

(iii) Failing to have a lead in his/her possession at the time shall not be a reasonable excuse for failing to do so.

For the purposes of this article a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.

An Authorised Officer of the Council or a Police Officer may only give a direction under this Article to put and keep a dog on a lead if such restraint is reasonably necessary to prevent a nuisance or behaviour by the dog is likely to cause annoyance or disturbance to any other person (on any land to which this Article applies) or the worrying or disturbance of any animal or bird.

D. Dog Exclusion Areas (except Beaches)

A person in charge of a dog shall be guilty of an offence if, at any time, he/she takes the dog onto, or permits the dog to enter or to remain on any land designated as a Dog Exclusion Area detailed in the Schedule below unless:

(i) He/she has a reasonable excuse for doing so; or

(ii) The owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his/her failing to do so.

E. Dog Exclusion on Beaches

If, at any time, on any land to which this article applies as specified in the Schedule below, a person takes the dog onto, or permits the dog to enter or to remain on, any land specified during the times specified in the Schedule, unless:

- (i) That person has a reasonable excuse for doing so: or
- (ii) The owner, or occupier or other person or authority having control of the land has consented (generally or specifically) to that person doing so.
- 4. A person who is guilty of an offence under this order shall be liable on summary conviction to a fine not exceeding Level 3 on the standard scale or a fixed penalty notice.

Liability to conviction for the offence may be discharged by the payment of a fixed penalty notice issued by an authorised officer or police officer. The amount of the fixed penalty notice shall be £100 and it shall be payable to South Hams District Council.

Where a fixed penalty notice is issued no proceedings will be taken for the offence before the end of the period of 14 days following the date of the notice. The person served may not be convicted of the offence if the fixed penalty notice is paid before the end of the 14 day period.

An authorized officer means an employee of the Council, or other persons who authorized in writing by the Council, or a Police Officer for the purpose of giving directions or carrying out enforcement under this order.

- 5. Nothing in this Order applies to a person who:
 - a. Is registered as a blind person in a register compiled under under section 29 of the National Assistance Act 1948; or
 - b. Is deaf, in respect of a dog trained by Hearing Dogs for Deaf People (Registered Charity no. 293358) and upon which that person relies for assistance or
 - c. Has a disability which affects that person's mobility, manual dexterity, physical coordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which that person relies for assistance.

Each of the following is a (prescribed charity):

- Dogs for the Good (Registered Charity no. 1092960)
- Support Dogs (Registered Charity no. 1088281)
- Canine Partners for Independence (Registered Charity no. 803680).

SCHEDULE

A. Fouling

- 1. Subject to the exception in 1(iii) above, this article applies to all land which is in the administrative area of the Council and which is:
 - Open to the air (which includes land that is covered but open to the air on at least one side); and
 - To which the public are entitled or permitted to have access (with or without payment).

B. Dogs on leads

- This article applies to all areas covered by Rule 56 of the Highway Code i.e., on the road, or on the pavement, or on a path shared with cyclists or horse riders
- Areas with retail premises designated as zone 1 under the Environmental Protection Act 1990 i.e., where there are 2 or more commercial / shop premises
- Car Parks
- Cemeteries and Churchyards
- 5. Any fenced, hedged or walled pond, area of water or nature reserve
- 6. Marked sports fields whilst organised sport is in progress
- 7. Areas delineated as formal gardens, and
- 8. Specifically the site known as Courtenay Park, Salcombe.

C. Dogs on leads by direction

- Subject to the exception in 1(iii) above, this article applies to all land which is in the administrative area of the Council and which is:
 - Open to the air (which includes land that is covered but open to the air on at least one side); and
 - To which the public are entitled or permitted to have access (with or without payment).

D. Dog Exclusion Areas (except Beaches)

- 1. This article applies to all land within the Council's administrative area comprising:
- Any fenced, hedged or walled children's play area
- Any fenced, hedged or walled bowling green
- Any fenced, hedged or walled tennis court
- Any fenced, hedged or walled skateboard or BMX park
- Any fenced, hedged or walled putting green
- any sporting or recreational facility pitch when sport is in play
- plus any other beaches (in addition to those included in the article below) that the Authority may wish to include in this Order from time to time.

E. Dog Exclusion on Beaches

- Land to which this article applies includes all beaches including the seashore, foreshore and any slope or staircase leading on to the beaches at the locations noted below:
 - i) Mouthwell Sands at Hope Cove

Between 1st May and 30th September inclusive between the hours of 10:00 and 19:00 in any 24 hour period.

ii) South Sands, Salcombe

Between 1st May and 30th September inclusive (24 hour ban) except during Ferry operating times when dogs are permitted to cross the Sands on a lead to embark and disembark to and from the Ferry.

iii) Part of Bigbury Beach from the lifeguard steps to the high tide mark to the east

Between 1st May and 30th September inclusive (24 hour ban).
